 - ii. Course materials as required
 - iii. Staff training
 - iv. Rooms for conduct of counseling
 - v. Necessary furniture.

- f) Provide assistance for conduct of study visits, field visits, etc.;
- g) Not realize any fee from the trainees in any form whatsoever;
- h) Incur expenditure on all operations/services as per the financial guidelines of SSC.
- i) Provide free of cost counseling and guidance to the trainees for 1 year after the training.

6. Responsibilities of SSC

The SSC shall:

- a. Develop and provide broad course outline to the Training Centre.
- b. Provide list of trainees allotted to each Training Centre or be entitled to ask training institute to generate applications.
- c. Provide norms and guidelines wherever necessary;
- d. Provide lump-sum grant to the Training Centres on per trainee basis at the rates fixed by the management.
- e. Provide timely clarifications regarding Academic Inputs and any other necessary information to the Training Centre.
- f. Shall ensure through proper co-ordination and consultation that the Training Centre provide quality training.
- g. Shall ensure that all amounts released under shall be disbursed to the Training Centre timely, and keep a track of the number of trainees attending the programs at Training Centre.


7. Force Majeure

In the event of non-fulfillment of the contract terms and conditions due to any reason of force majeure namely fires, wars, riots, strikes, natural calamities, etc., neither the Training Centre nor SSC shall be held responsible for any loss or consequential loss.


8. Indemnity

11. Breach of Agreement

SSC shall have the right to terminate the agreement with the Training Centre, in case the Training Centre either fails to provide the services successfully as mentioned in the agreement, or violates any of the clause mentioned in the MOU, or exploits the students or misuses the partnership with SSC in any way.

12. Amendment to the Agreement

The obligation of the Training Centre and SSC have been outlined in this agreement. However, during the operation of the agreement, circumstances may arise which call for alteration or modifications of this Agreement. These modifications/alterations will be mutually discussed and agreed upon in writing.

13. Period of Validity

This agreement shall be initially valid for three years from the date of signing the agreement and to be renewed subsequently by mutual consent of both the parties.

14. Arbitration

Any dispute arising with regard to any aspect of this agreement shall be settled through mutual consultations and agreements by the parties to the agreement.
